# How do I open an after school program?

The Network receives many requests from people who want to start their own programs. We suggest you first observe the programs that already exist in your community. Talk to the people who run them to get a true picture of the level of commitment required to run a high quality program. Most funding streams in California require that the provider have a relationship with the school or school district. If becoming an after school provider interests you, meet with your local principal to see if the school needs your services. If it does, contact the Regional Lead in your area (information available in this article.) If you want to open a licensed childcare center attend one of the orientations that Community Care Licensing holds.

# Brief history and funding streams of after school in California

## **Proposition 49 and Senate Bill 638**

In November of 2002, California voters passed Proposition 49, the After School Education and Safety, or ASES program. This required the State to offer \$550 million dollars each year to Kindergarten through 9th grade after school programs. In 2006 Senator Tom Torlakson authored Senate Bill 638. This bill allowed easier access to Proposition 49 funds by allowing for direct grants instead of reimbursements, reducing a 50% grant match to a 33.3% grant match, and increasing the daily per pupil rate from \$5.00 to \$7.50. It also raised grant caps so that existing programs can serve the same number of students. The bill was signed into law by Governor Schwarzenegger in September, 2006.

## 21st Century Community Learning Center

California also receives federal funding to administer the 21st Century Community Learning Centers program as well as the After School Safety and Enrichment for Teens (ASSETs) program.

# How does California define quality in after school?

The California AfterSchool Network in cooperation with the California Department of Education and a broad base of stakeholders has developed the **California After School Quality Self-Assessment Tool (QSA)**. The QSA Tool is available on the California Afterschool Network website. The tool can help you learn the components of a high quality program. It can be utilized as part of a staff-directed process to self-assess after school programs and create a plan for continuous program quality improvement.

# **Lights on Afterschool**

*Lights on Afterschool* is a project of the Afterschool Alliance. It is celebrated Nationwide in October to highlight the accomplishments and importance of after school programs. Thousands of programs across the state and the nation celebrate *Lights on Afterschool* by hosting celebrations at their program sites. Many programs invite parents, local legislators, law enforcement, and community members to see the benefits of after school program firsthand. We encourage each local program to host a local *Lights on Afterschool* celebration.

# The California Afterschool Challenge

The California Afterschool Challenge is an event hosted by the California School Age Consortium (CalSAC), and is modeled after the National Afterschool Challenge. It is an opportunity for out-of-school time providers, stakeholders, and advocates to urge the Legislature to continue to support after school and school-age care programs through personal visits with legislators.
